Every year the U.S Department of State uncovers hundreds of export violations, with unauthorized exports of technical data being one of the most common. Even with manufacturer or technical assistant agreements (MLAs and TAAs), the data shared often exceeds the allowable scope or was exported to unauthorized individuals. Without the proper controls these errors may also lead to unauthorized performance of defense services.

Export Control Reform (ECR) has intensified these challenges as the U.S Department of Commerce now has jurisdiction over more technology restricted for export. Under current regulations even high-level encryption is not an adequate security measure by itself. Each company must control who receives their export restricted data.

OCR TDSM™ (Tech Data & Services Management) assists with end-to-end export workflow of technical data/technology (tech data) and defense services. It is a single solution capable of meeting operational, compliance, regulatory and monitoring requirements, with required oversight and recordkeeping to meet USG requirements.

# **MANAGED FILE TRANSFER (MFT)**

- Transfer files to 3rd party Document Management System (DMS) replacing tech data with links to files
- Access permissions from DMS applied to TDSM
- Specify locations where documents will ultimately reside within a secure network
- Configurable trigger points from TDSM request approval to MFT tool, such as, recording the method of transfer
- Audit the transfer process to the data recipient

# **SECURE COMMUNICATIONS**

- Support secure access protocols and user authentication to Active Directory using LDAP, SAML 2.0 and Single Sign-On (SSO) tools
- Secure web forms support any secure 256 bit encrypted transmission and storage in a Relational DataBase Management System (RDBMS), such as, MS SQL or Oracle

## INTEGRATION WITH THIRD PARTY SYSTEMS

- Open standards, Java-based application
- Seamless real-time integration with Oracle, SAP, and other ERP, CRM, Supply Chain Management or other enterprise systems
- Integration support for any system including those client developed software


